- 6) In case of any false information in the proposal of the school the recognition will be cancelled.



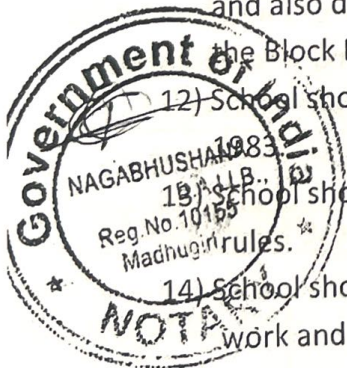

Conditions:-

- 1) The result of SSLC examination should not be less than 70% and also District average percentage.
- 2) Fire Extinguisher should be installed in the school to avoid fire hazard.
- 3) Incase school has started more division than the permitted division should be closed. Incase School wanted to start more division proposal may be submitted for permission.
- 4) The school has granted recognition as per Karnataka Education Act 1983 under 3 and 38 Section for granting recognition of schools under government notification no. ED 131 various 98 dated 24/11/1999 should follow the rules and regulations.
- 5) The school should get registration under Karnataka Education Societies (classification, registration and Teaching) rules 1995 section 4 and 5 school should have required building and place.
- 6) The school should get registration under Karnataka Education Societies (classification, registration and Textbooks) rules 1995 section 4,5,6 and 8 requires good building, place, water connection, toilet and other facilities.
- 7) School should provide required laboratory articles, library books, furniture, sports articles, maps and charts and also teaching aids and equipments.
- 8) School should have trained teachers and other staff members as prescribed by the Government.
- 9) School should constitute school managing committee or governing council as per Karnataka Education Act.
- 10) School should have fixed deposit as security amount as per Karnataka Education Act 1987.
- 11) School should collect the fee such as term fee, tuition fee, development fee as per rule 10(4) as per Karnataka Education Societies (classification, registration and Teaching) rules 1995 and also display the fee particulars, brochure on the notice board and also submit a copy to the Block Educational Officer/Deputy Director of Public Instruction.
- 12) School should provide playground facilities to the students as per Karnataka Education Act
- 13) School should provide the information of fee collection from time to time as per government rules.
- 14) School should follow teaching of textbook, medium, examination, no. of periods and home work and etc as per government model.
- 15) School should start in a place conducive for all.
- 16) School should maintain all registers and documents as prescribed by the Education department and as per the Education Act.
- 17) In high school all classes must have minimum 25 students.

- 25) Commissioner of Public Instruction Bangalore Letter No. C7 (3) PSA/ unauthorized schools 87/2014-15 dated 30-10-2014 with regard to safety and security of the children should invariably followed.
